I understand that part of my volunteer status at In the Beginning Preschool & Faith Mother's Day Out Program (FMDO) is that I am fully vaccinated by October 18, 2021, with one of the COVID-19 vaccines. Governor Inslee's Proclamation Decree on Wednesday, August 18 made it a legal and binding law for all Early Childhood Educators and Child Care Centers. Because our ECE program is a license- exempt setting under DCFY authority for the Bouncy Bunny's class (FMDO), the Director has made the decision to require every volunteer member to be vaccinated as a requirement for volunteering. This is the prudent and responsible decision to take for the health and safety of our students, staff, volunteers, and families to which we serve.

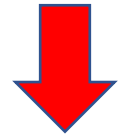
Exemptions are allowed for medical or religious reason only. Volunteers and staff members must show proof by filling out the exemption form and signed by your physician. If you are not vaccinated, you are required to wear a mask while volunteering with students and staff.
